Dear Jim and Dan, and dear Colleagues,

Following our notice for redundancy, we decided to resign from our roles of Programme Leads for the BA Business and Management and the MSc Management and MSc International Management as well as our Curriculum Lead roles for the Management and Organisation Division, with immediate effect.

We covered these roles for the last years and we helped to redesign and run these programmes as smoothly as possible even under the circumstances of a Pandemic and the excessive workload of so many colleagues who delivered modules and cared for the students in these programmes. We think you can understand that we cannot move on like this. The delivery of the programmes was dependent on the work of many colleagues who also received their notice of redundancy today, who have already resigned from the school in the last few months or who have taken VSS. Their teaching experience and their collegiality will be painfully missed. So far, the Dean and Deputy Dean of this school have not presented us with any idea of how to deal with this loss aside of their 'confidence' that all will be well.

The Dean sent an email to all students today reassuring them that their studies will not be disrupted and that the delivery and intended learning outcomes of the modules within these programmes will not be affected. As Programme Leaders with a strong sense of responsibility to our colleagues and to our students, we would like to clarify that this is far from the truth. What the Dean calls 'a small number of staffing changes' in reality means that several modules (both core and optional) in the BA Business and Management programme as well as the MSc Management and MSc International Management programmes are being dependent on the hard work and expertise of colleagues who have been made redundant, have taken VSS, or have resigned from their positions. It is unclear as to how their expertise will be covered in the next academic year. Below is a list of modules lead by colleagues made redundant, who have taken VSS or have resigned across these programmes. This is but a snapshot of the actual impact of the Case for Change as we have not included the impact on seminar delivery, marking or supervision at all levels.
